Project Title: Assessing Attitudes

Principal Investigator: Joseph S. Weaver, Ph.D. (Psychology Department)

Purpose of the Study

The purpose of this research is to determine if a commonly used psychological assessment (the implicit association test or IAT) can be implemented in an online survey.

Study Procedures

As part of this research, you will be asked to categorize words by pressing one of two keys on the keyboard. On some trials, you will need to categorize words as being a "pleasant" word or an "unpleasant" word. On other trials, you will categorize words as being an "insect" or a "flower." Sometimes, you will have combined lists (e.g., pleasant, unpleasant, insects, and flowers) and you may need to indicate both positive words and flowers with one key and both negative words and insects with another key. You will complete around 140 trials which will take about 20 minutes.

Possible Risks

There are no foreseeable risks associated with participating in this research. As in all research, there may be unforeseen risks to the participant. If an accidental injury occurs, appropriate emergency measures will be taken; however, no compensation or additional treatment will be made available to the subject except as otherwise stated in this consent form.

Participant Rights

If you choose to be in this study, you have the right to be treated with respect, including respect for your decision whether or not you wish to continue or stop being in the study. You are free to stop being in the study at any time. Choosing not to be in this study or to stop being in this study will not result in any penalty to you or loss of benefits to which you are otherwise entitled. Specifically, your choice not to be in this study will not negatively affect the possibility of earning course extra credit.

The participant is free not to answer any questions or respond to experimental situations that he or she chooses without penalty.
